BOD pH Total Suspended Solids Faecal Coliforms Nitrate-Nitrite Total Phenols Sodium Magnesium Total Arsenic Total Copper Total Iron Total Mercury Total Zinc Conductivity Ammonia Nitrogen Oil and Grease (visual) Sulphate Potassium Calcium Total Cadmium Total Chromium Total Lead Total Nickel

These samples should be collected at the beginning, middle and end of the discharge. This corresponds with what is required under the license.

Also, Please ensure that a spill report is filed as per the license.
