The Nunavut Water Board (NWB) has received notification from Ferguson Simek Clark on behalf of the Municipality of Pond Inlet, pursuant to Part F, Item 1 of Water Licence NWBPON9904, describing construction at the Hamlet's Sewage Treatment Facility. The proposed construction will involve the following activities:

- Repair of 230 m of the north berm interior slope;
- Removal and disposal of the existing outfall structure;
- Supply and installation of a new discharge structure and system;
- Elevation of lagoon retention berms to meet 2022 sewage generation;
- Installation of a clay liner and geotextile fabric into the lagoon;
- Installation of a new outfall, emergency overflow system & truck turn-around area; and
- Regrading of the site access area.

The NWB is accepting written concerns and comments with regards to this project before **August 27, 2002**. Thank you in advance for your quick response to this request. Please accept my apologies for any inconvenience that may result from the tight timeline for response, which is necessitated by the limited time available to the Hamlet for construction.
