Good morning Bhabesh,

Regarding the Qikiqtarjuaq renewal application: Although the Board received the answers to AANDC comments directly from you, however we are not aware whether or not AANDC was provided with those answers?

The main point (raised by NWB as well previously) was related to the Operation and Maintenance Manual for

Water, Sewage and Solid Waste Facilities, that was already submitted to the Board and gone to public comments in 2011, however the comments weren't addressed and the Plan wasn't approved at that time, and the same Plan was included with the application. From my understanding AANDC and the NWB were looking for the updated Plan prior to the issuance of the renewal licence.

My last email sent to you with this respect (including 2011 Comments) was in June 24th.

With respect to the Clyde River renewal licence: I am finalizing the draft water licence, going to the Board beginning next week, and if approved by the Board it may be issued in the end of next week, hopefully.

I hope it helps.

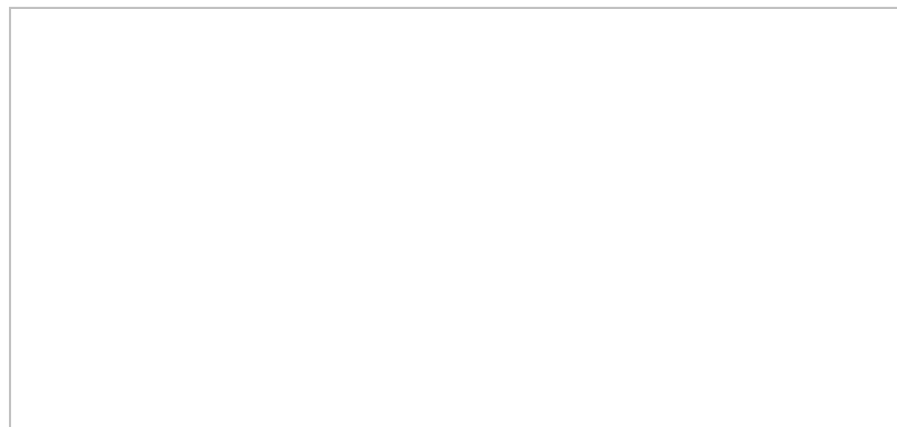
