I had several meetings this morning with our office, Hamlet of Resolute Bay and Jim Wall as well on this application. Here are the recommendations:

- 1. Application on Nov.24, 2006 is only for Utilidor system (Water and Wastewater).
- 2. GN-CGS is the owner of this facility and applicant for this license.
- 3. Once rehabilitation is completed and license is issued, with the mutual agreement with the hamlet, both license and the facility will be handed over to the hamlet following the regulations of NWB. Until such time, GN-CGS will be operating this facility and maintaining the license.
- 4. Hamlet will apply soon separately for license for the landfill site with the assistance of GN-CGS.
- 5. \$60.00 was paid already by GN-CGS to NWB. It is suggested to use \$30.00 for the application fees for the Utilidor system and \$30.00 for the future application of the landfill site so the hamlet needs not to pay anything.

I explained to Jim Wall and we are very much clear about it.
