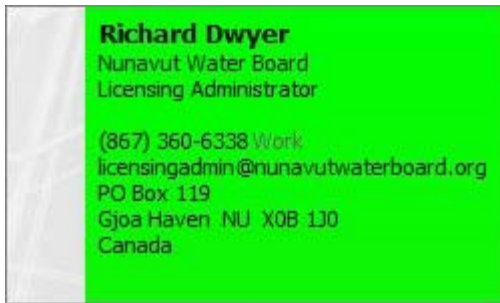

Good Afternoon Richard,

Resolute has three water Licenses:

1. **Airport Sewage Lagoon:** ED&T is handling this Project. We have no involvement. ED&T is the owner.
2. **Soliswaste management Facility (landfill):** Hamlet has applied for the license to use a facility built in about 2000 roughly 7km from the community. It was identified that the site is not technically suitable for the community.

Afterwards three sites have been identified. The consultant is right now working on the feasibility of these sites to select the best one. Right now the hamlet has no license for solidwaste management.

3. **Utilidor System:** GN –CGS owns this facility. We have applied for a license. It is still with the NWB review process.

Hope this will help.
