The NWB has completed its preliminary review of the application submitted on March 18, 2016, by the Government of Nunavut – Department of Community and Government Services (GN-CGS), on behalf of the Hamlet of Resolute Bay, to amend Licence No. 3BM-RES1520. The review determined that the following items must be clarified or addressed before the application could proceed to the next stage(s) of the licensing process:

The document entitled *Draft Resolute, Nunavut Dump Site Investigation, Hamlet of Resolute, Nunavut*; dated September 5, 2008, is in draft form. It should be noted that in accordance with the NWB's guidelines for processing applications, the Board does not consider draft versions of documents as part of an application. Therefore, a finalized version of the document should be submitted for consideration;


Final document is signed by the consultant and this is attached.

• Details regarding which federal departments requiring use of the waste disposal facility that is the subject of the amendment application and for which federal projects the use of the facility is required; and

The old buildings next to the Resolute Airport belong to NAV Canada. Their contractors are demolishing these old buildings and planning to store the metals of these buildings in the proposed waste site following Hamlet's new waste receiving by-laws.

• A map depicting the location of the waste site in question relative to the sewage lagoon site currently being operated by the hamlet / GN-CGS and the waste management sites currently being operated by Transport Canada. Confirmation is required on whether the waste disposal facility in question is at present being operated by Transport Canada.

The waste site under the existing Water Licence located next to the Resolute Bay Airport Sewage Lagoon belongs to Transport Canada (TC) and currently unused. TC is planning to decommission this facility following their own licence. This site is shown in Fig.-1; Appendix-A of the QA/QC plan and also as follows:



Apart from the above, the NWB notes that the following submissions, which are requirements under Licence No. 3BM-RES1520, appear to be outstanding and confirmation of their pending submission is required:

Part F, Item 4 of Licence No. 3BM-RES1520

The Licensee shall submit to the Board for review with the annual report, an addendum to the Spill Contingency Plan that addresses the following:

a. The specific name and address of the owner or person in charge, management or control of the site(s);

b. The name, job title and 24-hour telephone number for the person(s) responsible for activating the Spill Contingency plan;

c. Confirmation that a spill kit is available at the hazardous waste and bulky metals area. A spill kit is not available at hazardous waste and bulky metals area. A spill kit is kept at the Hamlet Garage.

Part G, Item 7 of Licence No. 3BM-RES1520

The Licensee shall submit for review, within six (6) months of Licence issuance, a Closure and Remediation Report for the site of the Solid Waste Facilities used prior to 2002. This report is to be stamped by an Engineer and describe the history of the site and its decommissioning, and also the Engineer's assessment of whether further reclamation is required at the site to mitigate the possibility of contamination to surrounding freshwater systems.

This report will be submitted 6 (six) months prior to planning for decommissioning of the existing Municipal waste sites. Right now we are uncertain when the new waste management facilities will be built.

Part H, Item 5 of Licence No. 3BM-RES1520

The Licensee shall submit to the Board for review, within ninety (90) days of the issuance of the Licence, a Quality Assurance/Quality Control Plan based on the guidance document Quality Assurance (QA) and Quality Control (QC) Guidelines For Use by Class "B" Licensees in Collecting Representative Water Samples in the Field and for Submission of a QAQC Plan

INAC (1996). The Plan shall include a cover letter from an accredited laboratory confirming acceptance of the Plan for the monitoring and analyses to be performed under the Licence.

QA/QC plan is attached with the support letter by the Accredited Lab.
