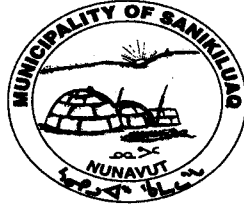

The above Contracting Group had applied to lease land in an area where Community considers Watershed under the Community Plan. The group above plans and in process to build a New High School within the community.

The purpose of this request for approval is that the group plans to bring in Residential Trailers via sealift for their Employees to reside in while constructing the school within 18 months. The size of the land for their trailers is 96 ft in length X 52 ft in width and would be set in an area where water drains to the lake, across from the Community Hall. I will be approaching Hamlet Council on their next May 21st meeting for their approval of the request. As a Lands Officer, I have been made aware that the trailers will be used as residential purposes only and we will make sure that no waste, debris and other contaminants will drain towards the lake.
