I am contacting you regarding the Hamlet of Sanikiluaq's application for water licence renewal. The application has been distributed and comments have been received. Before the NWB proceeds with the water licence renewal a response to INAC's comment regarding the requested volume of water is requested. INAC's comment is as follows and their submission is attached to this email for your reference:

"The Hamlet is requesting the daily use of less than or equal to 100 cubic metres of water. The Trow Associates May 2010 Design Brief submitted for the Hamlet's new truck fill station estimates an annual water use of 35,500 cubic metres. The Hamlet's request and Trow estimate are consistent, however, the INAC Water Resources Division suggests that water use growth over the last four (4) years and the next five (5) years has not been adequately considered. INAC recommends that the annual limit specified in a renewed Water Licence should be closer to 40,000 cubic metres per year pending agreement from the Hamlet."
