A. Background

On October 16, 2014, the Nunavut Water Board (the Board or NWB) provided notification of the Hamlet of Sanikiluaq's (the Hamlet) application to renew Water Licence 3BM-SAN1214 to allow for the use of water for municipal undertakings. Mr. Dibblee, Senior Administrative Officer, Hamlet of Sanikiluaq, and Bhabesh Roy, Municipal Planning Engineer, Community Government Services (CGS), Government of Nunavut has submitted this application on behalf of the Hamlet of Sanikiluaq.

Interested parties were asked to review this application and provide comments by November 16, 2014.
