The review determined that the following outstanding information requirements, relevant to the appropriate terms and condition in Licence 3BM-WHA0914, <u>MUST</u> be addressed before the NWB can proceed to the next stage(s) of the licensing process for the application:

- Copies of 2009, 2010, and 2013 Annual Reports as required under Part B, Item 1
- Copy of the Solid Waste Disposal Facilities Update Report as required under Part F, Item 1
- ➤ Copy of the updated, consolidated Operations and Maintenance (O &M) Manual consisting of previous submitted plans as required under Part F, Item 2. The updated manual should take into consideration the proposed expansion of the Waste Water Treatment Facility
- Copies of reports generated from annual inspections conducted by a Geotechnical Engineer for all facilities associated with water and waste as required under Part F, Item 4
- Copy of the Quality Assurance/Quality Control (QA/QC) Plan required under Part H, Item 13

The Proponent should note that Licence 3BM-WHA0914, which was issued on June 10, 2014, is set to expire on May 31, 2014. Accordingly, any renewal-amendment application submitted to the Board in support of the undertaking must address all new and outstanding requirements associated with the licence.
