On January 21, 2015 the Nunavut Impact Review Board (NIRB or Board) received Hamlet of Whale Cove's (the Hamlet) "Sewage Lagoon Expansion" project proposal from the Nunavut Water Board (NWB). On January 23, 2015 the NIRB received correspondence from the Nunavut Planning Commission (NPC) which indicated it had reviewed the application and determined that it did not change the scope of the originally reviewed project to an extent that would warrant a further review at this time.
