Re: Application Acknowledgement and Requirement for Notice of the Application for the Municipality of Resolute Bay Airport

Dear Mr. Roberts:

The Nunavut Water Board acknowledges receipt on December 6, 2001 of your water licence application for the Resolute Bay Airport. Your application includes the following items:

- executive summary in English AND Inuktitut
- application form
- supplementary questionnaire
- engineered drawings and maps
- Water Use Inspection Report, September 28, 2001

We require an application fee of \$30.00 in the form of a cheque made payable to "Receiver General For Canada". I trust this will be forwarded shortly.

This project is exempt from screening by the Nunavut Planning Commission and by the Nunavut Impact Review Board. It will, however, be distributed to various governing agencies, for their comments.

I have been asked by the Board to inform you that a notice of your application is required. This notice of requirement is based on Article 13.3.14 of the Nunavut Land Claims Agreement (NLCA), which states that the Board should take "...all steps necessary by way of notice...to provide and promote public awareness [of hearings]."

Accordingly, an application notice in both English and Inuktitut will be posted for a period of 30 days, with the following establishments in Resolute Bay:- Hamlet Office, QIA, HTO, and Co-op Store.

Upon request from the public, we ask you to make available, free of charge, copies of all documents pertaining to this application. Any person who is affected by this application or concerned with it, may submit a letter of concern, which must be submitted to the Board within the period of time shown on the public notice.
