The Nunavut Water Board's last record of water use fee payment was for 2015, can you confirm if payments were made directly to CIRNAC? As the Water use fee of \$30 per year, for the years 2016, 2017, 2018, 2019, 2020, 2021 and 2022 remain outstanding.
