1.0 INTRODUCTION

1.1 Purpose of Plan

The purpose of this Spill Contingency Plan is to provide a plan of action for all spills of hazardous materials that may occur at the B & J Fly Fishing Adventures Camp Facility located at Ekaluk River, Nunavut (Inuit Owned Land (IOL) Parcel CB-38/77; Latitude: 69°23'N; Longitude: 106° 13'W). This Spill Contingency Plan defines the responsibilities of key personnel and outlines procedures to effectively and efficiently contain and recover spills of hazardous materials.

Petroleum, oil and lubricating (POL) products that currently, or potentially, fall within the Scope of this Spill Contingency Plan are as follows:

- gasoline
- lubricating oil

1.2 B & J. Fly Fishing Adventures Environmental Policy

It is the policy of B & J Fly Fishing Adventures to fully comply with all applicable Acts and Regulations to ensure the protection of the environment of Nunavut. B & J Fly Fishing Adventures shall cooperate with other groups committed to protecting the environment and shall ensure that our employees, regulatory authorities and the public are informed on the policies and procedures we have developed to help protect the environment of Nunavut.

2.0 SITE DESCRIPTION

2.1 General Site Description of the JMS Supplies POL Storage and Retail Facility

This spill contingency plan is to be implemented at the B & J Fly Fishing Adventures Camp Facility located at Ekaluk River, Nunavut, Nunavut.

2.2 Petroleum Storage and Transport


POL storage locations shall be located a distance greater than 100 metres from the normal high water mark of any water hody, at the following GPS coordinates: Latitude: 106° 13'N; Longitude: 69° 23'W. The POL storage on site will have a total capacity of 100 L of gasoline stored in 20 L ULC-approved containers.

All fuel and oil are transported to the B & J Fly Fishing Adventures Camp Facility by boat.

3.0 SPILL RESPONSE ORGANIZATION

The following is a flow chart to illustrate the sequence of events in the event of a hazardous material spill occurring at the B & J Fly Fishing Adventures Camp Facility:



3.1 Spill Response Team

William Lyall, or his Designate, will serve as the Spill Response Coordinator for B & J Fly Fishing Adventures in the event of a POL spill. William Lyall will appoint and train appropriate personnel to make up the B & J Fly Fishing Adventures Response Team, which normally consist of the following personnel:

Spill Response Coordinator: William Lyall (or Designate)

Site Personnel: Will generally vary from 1-3 people throughout the year

The responsibilities of the Spill Response Coordinator are as follows:

- Assume complete authority over the spill scene and coordinate all personnel involved.
- Evaluate spill situation and develop overall plan of action.
- 3. Activate the B & J Fly Fishing Adventures Spill Response Plan.
- 4. Immediately report the spill to the NWT 24-Hour Spill Report Line (867) 920-8130, regulatory agencies, and the Senior Administrative Officer of the Hamlet of Cambridge Bay
- 5. Obtain additional spill response resources from the Hamlet of Cambridge Bay if not available on site for spill response.
- 6. Provide regulatory agencies with information regarding the status of the clean up activities.
- 7. Act as a spokesperson on behalf of B & J Fly Fishing Adventures with regulatory agencies, the public and the media; and
- 8. Prepare and submit a report on the spill incident to regulatory agencies within 30 days of the event.

4.0 SPILL REPORTING PROCEDURE

The On Scene Coordinator must be notified immediately of any spill either by satellite phone, radio, or in person.

The following is the spill reporting procedure:

- Report immediately to the 24-Hour Spill Report Line Phone (867) 920-8130, Fax (867) 873-6924;
- Report immediately to the INAC Inspector in Iquilia at 867-975-4298;
- 3. Notify the Senior Administrative Officer of the Hamlet of Cambridge Bay; and
- 4. Fill out the NWT Spill Report Form within thirty (30) days of the spill event occurring.
