I am writing you regarding the application for Water Licence Renewal (Application) for the Elu Inlet Lodge, submitted to the Nunavut Water Board (NWB) on June 18, 2015. I am the Tech Advisor assigned to this file.

A preliminary technical review of the Application found the following deficiencies:

1) Inuktitut Summary of the Application is required

Inuktitut Summary of the Application was not found. Please, provide with an Executive Summary of the Application in Inuktitut.

2) AANDC's Inspection Report on July 13 2012, report addressing issues is required

AANDC's Inspection Report on July 13 2012 described some matters of Non Compliance with the Act or with the Licence conditions. A short report, including photographs in order to confirm the issues were addressed was requested to be submitted by September 30, 2012.

Evidences that the report was submitted to the Inspector are not found at the nwb ftp site. Please, submit a copy of the mentioned report.

3) Water use needs to be clarified

Water use under the expired Licence is authorized up to 50 cum.

The Application is requesting 70 gallons/ day of Water (equivalent to 2.6cum/day).

However, Annual Reports state the following water use:

Year 2004, water use of 72 cum,

Year 2005, water use of 84 cum and

Year 2009, 63 cum.

Please, clarify whether this Water consumption is referred to seasonal or to daily consumption

The Application will not be processed until these issues are addressed.
