Dear Christine

I have attached my final report for the year 2011 to the water board sent March 31, 2012 along with the covering **email** sent with it below. At the time it was my expectation that the water board would cancel Cawker & Young Outfitting's license/permit and Aziz would need to apply for a license/permit in any name he wished. It was my belief because the email, below was quite clear outlining both the sale of the lodge, who I sold it to and where he could be found. The email also makes it clear that this would be the final report. I don't believe Cawker & Young Outfitting Ltd. had any obligation to assign the water permit to anyone. It is not reasonable for anyone to believe that after the sale of the lodge Cawker and Young Outfitting Ltd. would want to continue holding the water license/permit. Again my expectation was if the Water Board felt Cawker & Young needed to do something more after receiving my email with the final report they should have said something then not now, 19 months after receiving the report.

Aziz Kheraj is a well respected business man and politician within Nunavut and a resident for many years and was easily reachable by the Water Board should they want to reach him.

My belief is that this slipped through the cracks both at the Water Board and by Aziz. An honest mistake easily remedied.

I stand ready to assist if I can. The problem I see is that Cawker & Young Outfitting Ltd. no longer exist and have not for quite some time. I am not sure how Cawker & Young can apply

for an assignment or how I can sign off on it as an officer of a company that does not exist. In looking at the assignment document it appears that it is very similar if not exactly what Aziz would have to supply the board if he were applying for a license/permit directly. All the players know when Aziz purchased the lodge and that he has made improvements and has demonstrated that he is more than willing to work with the board to get everything in order.

The ball is in Aziz's corner to make the reply to the report and I have been assured by him that he will. The ball is in the Water Boards corner to issue him a license/permit. I don't see that it has to be all that difficult.
