

# HAKONGAK OUTFITTING Byron Bay Camp



The hunting camp will be located at Byron Bay approximately 87 air miles west of Cambridge Bay on Victoria Island. The camp will be at least 2 km from the closest fresh water river. Our camp will consist of four 8' x 10' canvas tent frames and one 12' x 14' canvas tent frame. The following fuel will be used only for ATV and boat usage purposes: GASOLINE, about 600L or three drums of gasoline will be necessary for our hunting season, the gasoline will be contained in 208 litre fuel drums (drip pans will be available during fuel transfer by hand pump) and we will also have up to four 201b propane tanks for cooking purposes at the camp, the propane tanks are sealed containers.

## Organization:

George Hakongak, owner/operator of the camp, one head guide, camp attendant and camp cook.

It the event of a gasoline spill, the camp attendant on site will immediately try to contain the spill and if needing assistance will ask the camp cook to help in any way while I and the head guide are out on the hunt with the clients.

- evaluate the scale of the spill;
- proceed to cleaning with available on-site spill kit;
- report the spill according to NT-NU spill report procedure

## Response Plan:

The first person at the site will ensure safety of himself and those near the site. Next he will notify the owner/operator about the spill on his return to the camp.

#### Gasoline:

If possible and safety permits, stop the flow and eliminate ignition sources. Gasoline forms vapours that can ignite and explode. No smoking is permitted when responding to a gasoline spill. Use sorbent material to soak up the spill. All contaminated water, soils, clean up supplies, and absorbent materials will be stored in heavy duty plastic bags. The bags will be stored in ventilated areas away from incompatible materials.

- 1. Fill out "SPILL REPORT" copies of spill report form will be at the camp.
- 2. When transiting back to Cambridge Bay at the end of the hunting season, follow up by sending a copy of the spill Report to FAX # (867) 873-6924
- 3. The local wildlife officer will be made aware of any spill via Iridium telephone and a copy of the spill report will be given to them. Local telephone number in Cambridge Bay (867) 983-4167/4164

For any spill occurrence, a detailed report should be submitted to the local wildlife officer no later than thirty (30) days after initially reporting the event. This report should include the amount and type of spilled product, geographic coordinates, and the measures taken to contain and clean-up the spill site.

## Spill Kit:

We will have:

- rubber gloves
- disposal bags
- sorbent material for gasoline spills
- empty 45 gallon drum for container
