I do not have an incinerator in camp. We use 45 gal. burning barrels.

As noted, I have had the lease at Henik since 2002 and the camp since 2004-2005. It is a tourism camp and is also made available as a rental property for exploration companies, government, etc. It is a very small camp with minimal activity at the site. Maybe 3-4 weeks per year.

I believe that the NPC did process a conformity check when we applied for the commercial lease with KIA. As stated in my application, we have no plans of removing the camp and will be applying for a 10 year extension to the current lease.

PLEASE NOTE THAT WE HAVE A COMMERCIAL LEASE IN PLACE WITH THE KIVALLIQ INUIT ASSOCIATION AND HAVE GONE THROUGH THE ENTIRE REVIEW PROCESS. I DO NOT UNDERSTAND WHY I HAVE TO GO THROUGH THE SAME PROCESS AGAIN WITH NPC AND NIRB.

I provided the same information in 2006 for our Edehon Lake camp and the process was approximately 30 days. We received a 5 year license so I am wondering why this application package is no longer acceptable as it is identical to the package submitted in 2006??

I am a small Inuit owned company and would like to be given an opportunity to use the camp for my caribou hunts this fall.

I noted 20 persons just to cover it off in case I have a large group but in most cases, I will have less than 10 people in camp.

Good morning;

The Nunavut Water Board (“NWB”) acknowledges receipt on July 3, 2010 of your new water license application for the Northern Networks Ltd. Camp Project, file number 3BC-NNL----

We undertook a preliminary administrative review of your application and conclude that, in accordance with approved legislation under the *Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada* (“NLCA”), it does not contain sufficient information for the NWB to commence processing the file at this time. Specifically, we are asking you to provide the following:

- A detailed spill contingency plan should be provided. The plan should include a title page, table of contents, dated prepared, effective date, background information on the site and project, emergency contact numbers, a detailed site map depicting sill kits, sumps, nearby water bodies, fuel caches, etc; measure to prevent and contain spills. An example of a Spill Contingency Plan is attached.
- Background information on the type of incinerator that will be used for combusting sewage and solid wastes should be provided. Environment Canada’s Technical Document on Batch Waste Incineration is attached and it may help in the selection process.
- Rationale for requesting daily water use of 300 m3/day should be provided. Application states that the water will not be used for drilling but for domestic purposes only, i.e. to support 20 persons; and

- An abandonment and restoration plan should be provided
- NIRB Screening Decision (or confirmation in writing that a NIRB screening is not required)
- NPC Conformity (or confirmation in writing that an NPC Conformity is not required)
- Administration Fee \$30.00
- Water Use Fee \$30.00

We will resume the processing of your application once we receive the requested information. The application and summary are attached for NPC & NIRB reference.
