Good morning,

On July 3, 2010 the Nunavut Water Board ("NWB") received a new water license application for Northern Networks Ltd. municipal type water use and waste disposal associated with a camp.

If Northern Networks Ltd. intends to continue with this project, the NWB requires the following to consider the application complete:

1. A detailed spill contingency plan should be provided. The plan should include a title page, table of contents, dated prepared, effective date, background information on the site and project, emergency contact numbers, a detailed site map depicting spill kits, sumps, nearby water bodies, fuel caches, etc; measure to prevent and contain spills.
2. Background information on the type of incinerator that will be used for combusting sewage and solid wastes should be provided.
3. An abandonment and restoration plan (A&R Plan) should be provided
4. Nunavut Planning Commission determination on land use plan conformity is also required

Northern Networks Ltd. is reminded that in accordance with Article 13.7.1 of the Nunavut Land Claims Agreement .... “With the exception of domestic or emergency use of waters as set out in Section 5 of the *Northern Inland Waters Act RSC 1985, c. N-25*, no person may use water or dispose of waste into water without the approval of the NWB”.
