Good afternoon Ryan,

The Preliminary Technical Review carried out on the above-mentioned file has determined that the following issues should be addressed, the tech in charge of the file, Sean Joseph will be giving you a call:

The Spill Contingency Plan should be revised to include the following:

- the effective date of the plan as well as the date prepared and date revised;
- a copy of the NT-NU Spill Report Form, which can be accessed using the following link: <http://www.gov.nu.ca/env/ntnuspill.pdf>. In addition add **after step 4** of the section of the Plan that deals with the **Coordinator's Responsibilities**, a step for filling out the Spill Report Form;
- a detailed site map in an appropriate scale that depicts camp infrastructure, nearby water bodies, spill kits and any other relevant information;
- information on the quantities of hazardous substances stored on site;
- Information on the contents of spill kits;

- the following contact numbers in section 3.2 of the Plan: Department of Fisheries and Ocean Canada, Nunavut Water Board, and the Kivalliq Inuit Association; and
- copies of the MSDS sheets for gasoline and lubricating oil or state in the plan the location(s) where can be found.

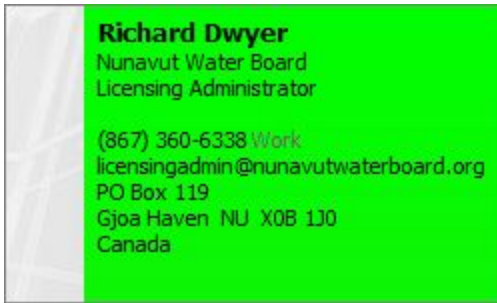
The Abandonment and Restoration should be revised to address the following:

- Clarify whether any drilling will be conducted under this Licence; section 2.8 of the Abandonment and Restoration Plan mentioned drill cores will be collected and stored within the drill-core area of the camp and that water used during drilling will be disposed of in a specific way; however, page 3 of the water licence application indicated that no drilling will be undertaken/drill water produced;
- Section 2.1 of the Plan refers to two table, Table 2-1 and 2-2; however, table 2-2 appears to be missing;
- Modify the **Table of Contents** to reflect information in the plan. For example section 2.7, 2.9 and 3.8 are missing in the Plan yet they are listed in the Table of Contents. List of Appendices should also be modify to reflect the contents of the Plan;
- Include the effective and dates revised;

The Water Licence Application should

- Page 4 of the application states that 300 cubic metres per day of water will be required for domestic use. Clarifications on why that daily volume of water is required given that the camp is designed to accommodate only 20 persons.
- Confirmation on treatment or disposal method for camp sewage is required: Page 5 of the Water Licence Application states that sewage will be burned, treated with lime and buried while section 2.3 of the Abandonment and Restoration Plan states that a portable toilet will be used.
