
Recommendation:

(R-01) CIRNAC recommends the licensee add map that details the location of spill response equipment on site to the Spill Contingency Plan.

2. List or inventory of hazardous materials on site

Comment:

List of fuel and hazardous materials



Recommendation:

(R-02) CIRNAC recommends the licensee provide a list of all hazardous materials to be held on site and to include that in the Spill Contingency Plan. Any and all fuel and hazardous material must be kept in a secondary containment. Additionally all fuel transfer areas but include a method for capturing spills during the refueling process.


Recommendation:

(R-04) CIRNAC recommends the licensee add a Spill Report Form to the Spill Contingency Plan.

5. Abandonment and Restoration Plan

Comment:

CIRNAC during their review of the document supplied with the application noted that there did not appear to be any information on Short term closures or final closures of the camp and facilities. Period of care and maintenance or periods when the camp may not be used for a prolonged period should be covered by a plan to ensure that material left on site are monitored.



Recommendation

(R-05) CIRNAC recommends the licensee submit an plan to cover short term closures, periods of care and maintenance or final abandonment Plans.

6. Monitoring Program

Comment:

CIRNAC noted that included in the supplied supporting documents no details on the monitoring of water sources or waste disposal areas was provided.

Recommendation

(R-06) CIRNAC recommends the licensee submit a up to date Monitoring program with locations of water source and waste sources.

7. WATER USE INSPECTION REPORT FORM July 9 2013

Comment:

In reviewing an Inspection report completed at the site in 2013 (last period the camp was in licensed use) the reviewer noted the following;

WASTE DISPOSAL

Comment: During the inspection the following was noted;

☐ The incinerator area is littered with debris and garbage. Specifically domestic waste such as diapers, plastic and food scrapes

Recommendation:

(R-07) CIRNAC recommends the licensee implement as included in their submission package the use of an incinerator capable of disposing of domestic camp waste and other burnable garbage such as papers, non-treated wood.
