Executive Summary

The 2017 annual report to the Nunavut Water Board (NWB) is a requirement under the expired Licence Number 3BC-ALT1015 Type "B", Part B, Paragraph 1. This annual report is for Canadian Forces Station (CFS) Alert, Nunavut. The Licence was issued on August 4th, 2010, to the Department of National Defence (DND) – 1 Canadian Air Division, Winnipeg, Manitoba. As 8 Wing – Canadian Forces Base (CFB) Trenton, Ontario, oversees CFS Alert, 8 Wing Trenton is filing the annual report on behalf of the new DND licensee, Real Property Operations (RP Ops) - Assistant Deputy Minister of Infrastructure & Environment (ADM(IE)). A renewal and amendment application was submitted in 2015 under 8AC-ALT---- Type "A"; the process is on-going.

For 2017, the average daily water usage at CFS Alert was 546 m³. This usage is above the 185 cubic meters daily water usage allowed by the NWB Licence. The daily water usage amount being reported is identical to the daily intake amount of raw water from the source at Upper Dumbell Lake. A large portion of this usage water is directly returned (raw and untreated) to the source concurrently to the intake process, the average return amount was 465 m³/day. This constant circulatory (return) flow of the raw water prevents freezing damages to the water pipelines. The average daily water consumption amount was 80 m³. The total annual quantity of water used in 2017 was 198,993 m³.

Hazardous wastes (waste fuels, waste oils, waste alcohols/glycols, lead, paint, asbestos, batteries and ansulite) were backhauled from CFS Alert in 2017 for disposal outside of Nunavut in Ontario, by external contractors. Non-hazardous domestic wastes produced from CFS Alert were directed to the designated Main Station Landfill & Millionaire's Dump. All sewage were directed to the Sewage Terrace System.

The Inspectors from Indigenous and Northern Affairs Canada (INAC) completed a Water Licence Inspection on 24 June 2017. A Compliance Plan in response to the inspection is submitted within this Annual Report.

The sampling requirements for the 2017 CFS Alert Surveillance Network Program were implemented from June to September. Complete runoff or ground seepage sampling could not be fully conducted in June and July due to typical summer

evaporation of the polar desert climate and the poor water retention properties of the tundra. An attempt by the sampling team to arrive at CFS Alert in August was unsuccessful resulting a mission delay until early September. By early-September, winter conditions had returned earlier than anticipated, effectively ending the sampling campaign. Continuous effort in timing and planning will be made to ensure a successful 2018 CFS Alert Surveillance Network Program reflecting DND's positive commitment to demonstrating compliance to the NWB Licence.
