Good morning Dave,

We are planning to work with FSC, Mr. Rob Kent out of Yellowknife, to put together the licensing package for Alert. They are working on the solution for sewage treatment in Alert, so they are well positioned to gather the relevant information for putting the licensing application together. While, I fully understand the need for completing the licensing requirement for Alert, I am still uncertain of what should be done for Eureka.

In my e-mail to you dated September 26, 2008, I provided the following information for Eureka:

"DND draws its water from the active Environment Canada (EC) facility and trucks it to the DND site approximately 2 to 3 km away. At that site, wastewater from the main building flows through a digester before it is deposited into a DND sewage lagoon (not the EC sewage lagoon). It appears, therefore, that the DND sewage lagoon is not licensed. Not all wastewater generated at the site is deposited in the DND sewage lagoon, however. Wastewater from the Weatherhavens (sleeping and shower facilities) is trucked back to the EC compound and deposited in the EC sewage lagoon."

I then asked you the following question:

In your response dated November 12, 2008, you provided advice on Alert, but I'm still unclear of the direction for Eureka. I want to make sure that we are doing everything that you require so that we leave no stones unturned.

Can you please provide clarification on Eureka?

Your attention to this matter is greatly appreciated.

Hello Ken,

I received a call this afternoon from Mr. Ron Kent with FSC in Yellowknife with respect to the Alert facility and the sewage treatment. I provided him with a copy of the Inspectors Direction from our public register as he indicated that he hadn't seen it and had some questions on it.

As far as application for the licence, it should be put together as soon as possible and should include all aspects of the facility with respect to water use (water supply) and waste disposal (sewage, solid waste, landfarming if applicable, and fuel storage (complete with a Spill Contingency Plan)). At a minimum, an application form, supplementary questionnaire, executive summary (both english and inuktitut) should be provided. Any facilities already in place (water and waste disposal) should be part of the document submission compete with as-built drawings, signed/stamped. There isn't a specific questionnaire for the type of facility you are applying for, however if you use the one for municipalities and provide info for the relevant areas, that should suffice.

Good afternoon Mr. Hohnstein,

Sorry for the delay in responding. To answer your questions, I provide the following:

I'm not aware of any other correspondence in addition to the Inspector's Direction.

The DND facilities in Eureka are only operational for a few months out of the year. For the rest of the year, it is unmanned.

DND draws its water from the active Environment Canada (EC) facility and trucks it to the DND site approximately 2 to 3 km away. At that site, wastewater from the main building flows through a digester before it is deposited into a DND sewage lagoon (not the EC sewage lagoon). It appears, therefore, that the DND sewage lagoon is not licensed. Not all wastewater generated at the site is deposited in the DND sewage lagoon, however. Wastewater from the Weatherhavens (sleeping and shower facilities) is trucked back to the EC compound and deposited in the EC sewage lagoon.

Based on the above, am I correct in suggesting that we don't need a license for drawing the water, but we do need a license for disposing the wastewater?

In terms of Alert, I have correspondence in my possession indicating that the process to license the facilities there is underway. Mr. Ron Bailey was corresponding with your office on this issue as recently as February 2008. I sent him an e-mail today to ask if he is still pursuing this, but haven't received a reply yet. From that correspondence, it appears that a Spill Report Protocol needs to be submitted with the Alert application. Is this also true of Eureka? Is there other documentation that needs to be submitted as well?

Please advise.

On Monday, September 8, 2008 I had called your office with regard to the inquiry below and left a message for you to get back to me when you were available. I thought I would followup with an email and present you with a few questions to help me in answering yours.

I reviewed the Inspector's Direction that was referred to from July 15, 2008 following an inspection of facilities under the Licence 3BC-EUR0611. This Licence has been issued to Environment Canada for the Eureka Weather Station. This Licence is for the use of water and the disposal of waste via Solid Waste Disposal Facilities and the Sewage Disposal Facilities.

As mentioned in my voice message, I am a bit confused as to the facilities referred to in the Inspector's Direction, issued to yourself (Canadian Forces Base Alert), discussing the above licence. Is there other correspondence I am unaware of?

If there are no other facilities involved here, it may just require a clarification as to which facilities are licenced under 3BC-EUR0611 and who is actually using them. It appears from the explanation below, that the facilities being discussed are the Eureka site facilities, and as such are currently licenced. If Env. Can. is not actually using the facilities, but DND, then the simple solution would be, as Richard has indicated, to have Env. Can. provide DND with some form of "use of facility" agreement which would require DND to operate under the terms and conditions of the Licence, however Env. Can. would remain responsible for the site. In your email (below), you indicate that DND is utilizing EC's water source, however the sewage lagoon is a DND facility. Is this the same facility as that which is licenced under the EUR Licence? Clarification is needed. Are there any facilities at ALERT that should be licenced? The NWB does not have any record of Licensing activity for this location.

From the information provide, it does not appear that any other licence applications are required for the Eureka facilities. If the Eureka facilities are to be transferred to DND, then the "Assignment" forms would be necessary. However, I do not believe that is the case.

Please give me a call at your convenience, (780) 443-4406 , to discuss this matter further and determine which direction DND is required to go in order to address the Inspector's requirements.

> Canadian Forces Station Eureka is a seasonally manned facility located
> on Ellesmere Island and used primarily in support of an operation
> which involves the annual maintenance of remote telecommunication
> sites between Eureka and Alert. Between 75 and 100 people occupy the
> site for approximately three months each year. Water is supplied by
> the local Environment Canada facility and sewage is disposed of in a
> Department of National Defence sewage lagoon. Fuel is flown in and
