Hi Brian and Phyllis,

There seems to be a bit of confusion here on our side of the fence with this particular application, as it is unclear why NPC would be forwarding a Type B NWB licence application to NIRB for screening, or why NWB would be awaiting some sort of confirmation from NIRB that screening is not required.

If a "project proposal" consists of only a Type B NWB licence application, then it is exempt from the requirement for NIRB screening (NLCA Schedule 12-1 item 5) and does not need to be sent to our office for any sort of verification of this. If a project proposal consists of a Type B NWB licence application and some other sort of authorization which is not exempt from the requirement for screening, then it should be sent to NIRB and we will be sure to copy NWB with our notice of screening, including the NWB file number if possible. In this instance it looks as though this is a Type B application for municipal water use at Eureka, and as such is presumably the only authorization required and is exempt from NIRB Screening.

On occasion NIRB will issue formal correspondence to an authorizing agency advising that an application is exempt from the requirement for NIRB Screening pursuant to NLCA Schedule 12-1, but our only reason for doing so is for proposals in areas with no approved land use plan, as some AAs are less familiar with interpreting NLCA Schedule 12-1 than the NPC. We do not wish to make a habit of issuing a letter to the NWB for every Type B licence application to verify something that the NWB is capable of determining on its own, as it's extra work for us and creates an unnecessary addition to the licensing timeline. I realize that the NWB's application forms require a proponent to supply written confirmation from NIRB if screening is not required, but again this is not something we're prepared to keep doing without a clear reason for it. I would suggest that this may need to be clarified between our organizations more formally in the near future.
