Good Morning Isa Qamaniq-Mason

I am the senior project manager for ECCC working on the runway project in Eureka. I believe Jean-Philippe Cloutier-Dussault has spoken to you recently on a contamination issue which was discovered on site. With the short construction window in Eureka we are requesting approval to proceed with this temporary stockpiling solution ASAP please see our consultant statement below;

Environment and Climate Change Canada (ECCC) is currently rehabilitating the runway at the Eureka High Arctic Weather Station. The goal of the project is to improve the condition of the runway, airside aprons and the access road. The project is being conducted under Land Use Permit N2017N0017¹ and Water Licence 8BC-EUR1621².

During construction, the runway rehabilitation contractor discovered petroleum hydrocarbon impacted soils in an excavation. As a temporary measure to address this impacted soil and also keep construction of the runway progressing, ECCC proposes to construct a lined temporary stockpile of the contaminated soil. The soil stockpile will limit risks to human health and the environment while longer-term measures are developed and is consistent with Requirement 58 of the Eureka Land Use Permit. The contractor will continue to excavate the area in question as required by the runway rehabilitation specifications and expects that this may result in a maximum volume of 6,000 m3 of contaminated soil.

The soil stockpile will be constructed according to the Station's Water Licence and the Land Use Permit. More detailed drawings and a memo with construction requirements are currently being produced by a consultant and will be forwarded on July 24, 2020.

[1] The Land Use Permit was granted July 4/August 8, 2017 and conditions annexed on June 18, 2018.
