Hello Tyler,

A modification request is submitted at least 60 days prior to initiating the proposed modification.

Issued-for-Construction drawings stamped and signed by an Engineer are a part of a notice of construction and required for Board review at least 60 days prior to proposed construction.

Updated management plans for facilities requested to be modified are best to be provided with the modification request. However, if it is not possible to do so, please outline in the modification request how ECCC plans to update the operations and maintenance manuals and the *Interim Abandonment & Restoration Plan* as a result of these modifications. Then, the updated manuals and plans may be provided with the notice of construction.

As-built drawings are required to be provided within 90 days after construction.
