Hello Jean-Philippe,

If no sludge is removed from the trench, no monitoring for sludge quantity at EUR-9 is required (same situation as effluent discharge from the trench).

ECCC may apply for a Licence amendment; however, as there are no obligations for this sort of monitoring with the proposed process setup, you may continue as is. The Board prescribed this monitoring as a precautionary measure in case sludge ever makes its way into the trench.
