Hello Meagan,

The Radar site at Brevoort has an incinerator. If there are a lot of people on site and the incinerator is working well there should be very little waste going to Iqaluit. Maybe 1 or 2 bags a week of ash from the incinerator. If the incinerator is not working properly there could be 20 bags of household waste a week being back hauled to Iqaluit. During the quarterly maintenance there would be 3 or 4 bags of waste for 1 week.

There is no incinerator at Cape Dyer so if there are a lot of people on site there would be 20 bags of household waste backhauled every week. During the quarterly maintenance there would be 3 or 4 bags of waste for 1 week.

There are only large numbers of people onsite during special projects during the summer for 6 to 8 weeks and only special projects do not take place every summer at these sites. All hazardous waste is shipped south.

Hello Megan,

Nasittuq is the operations and maintenance contractor for the North Warning System. There are two North Warning System radar sites (one at Cape Dyer and the other on Brevoort Island) that are maintained from an office in Iqaluit. These sites are unattended except for during quarterly maintenance and special projects. Waste is backhauled from activities on these sites to Iqaluit. Hazmat is brought south and disposed of here. Waste, mostly food waste and paper waste, are picked up from the NWS office in Iqaluit (west of the air strip) along with the waste from that office.

Recently we renewed our Nunavut Water Board (NWB) Water Licences for the two sites. One condition

is that the Board be provided with "documented authorization from all communities receiving wastes from the project". Could you please provide me with this authorization.
