**RE: Revised Spill Contingency Plans for Licenses 3BC-BAF0919, 3BC-CAM0919, 3BC-DYE0919, 3BC-FOD0919, 3BC-FOH0919 and 3BC-SHE0919**

Dear Ms. Chawner,

The Nunavut Water Board (“NWB”) received six Spill Contingency Plans for the above files on November 5, 2009. On November 25 and November 26, 2009 the NWB acknowledged receipt of the Plans and distributed them for a public review period with a deadline of January 4, 2010. Submissions were received from Indian and Northern Affairs Canada, Environment Canada and the Government of Nunavut – Department of Environment. No concerns were expressed with the Plans. Following a review of the plans and submissions, the documents fulfill the requirements of the Licenses and have been approved by the NWB under the following motion numbers:

1. 3BC-BAF0919 “Spill Contingency Plan for BAF-3 (Brevoort Island, Nunavut)” dated November 4, 2009 under 2009-18-L01:
2. 3BC-CAM0919 “Spill Contingency Plan for CAM-M (Cambridge Bay, Nunavut)” dated November 4, 2009 under 2009-18-L02:
3. 3BC-DYE0919 “Spill Contingency Plan for DYE-M (Cape Dyer, Nunavut)” dated November 4, 2009 under 2009-18-L03:
4. 3BC-FOD0919 “Spill Contingency Plan for FOX-3 (Dewar Lakes, Nunavut)” dated November 4, 2009 under 2009-18-L04:
5. 3BC-FOH0919 “Spill Contingency Plan for FOX-M (Hall Beach, Nunavut)” dated November 4, 2009 under 2009-18-L05:
6. 3BC-SHE0919 “Spill Contingency Plan for CAM-3 (Shepherd Bay, Nunavut)” dated November 4, 2009 under 2009-18-L06:

In its comments, the Government of Nunavut – Department of Environment advised that its

Manager of Pollution Control be included under emergency contacts. The Licensee is advised to include this contact information in future versions of the Plans.

In review of the Plans, it was noted that there are requirements for Feasibility Reports for the installation of a remote leak detection system capable of generating a timely site response to the event of a fuel leak during unmanned periods for 3BC-BAF0919, 3BC-DYE0919, 3BC-FOD0919 and 3BC-SHE0919 within sixty (60) days following issuance of the Licenses. The Licensee is reminded of this requirement and is advised to inform the NWB on when the Reports should be expected.
