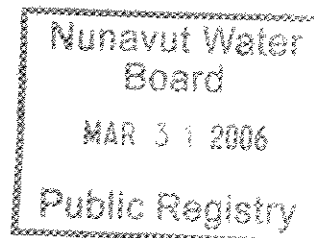

### Cambridge Bay – North Warning System Long Range Radar Site – CAM-M

The annual operation and maintenance (O&M) activities at Cambridge Bay during the reporting period included the quarterly preventive maintenance, fuel tank cleaning and inspection, building and radar tower inspections and routine infrastructure assessment, and fuel resupply.

#### Water Use and Waste Disposal

The average daily water use at Cambridge Bay during this reporting period was well below the stipulated maximum volume as indicated in the NWB water licence. The waste management was consistent with the Nasittuq Environmental Protection Plan, meeting the terms and conditions stipulated in the NWB water licence.
