Dear Mr. Kalen:

The Nunavut Water Board (“NWB” or “Board”) has completed technical reviews on the following documents for the above-mentioned project located 2.5 kilometers west of the community of Cambridge Bay: .

1. 2010 Annual Report Required under Part B, Item 1 of the Licence terms and conditions ;
2. QA/QC Plan for Sampling from CDL-2 (Final Discharge Point of Sewage Treatment Facility) at CAM –M; and
3. 2010 Inspection Report.

2010 Annual Report

The 2010 annual report was received on March 30, 2011 and distributed, for information, on April 12, 2011; no comments were received regarding the report at the time of this review. The review found that the report is complete and consistent with the reporting requirements of licence 3BC-CAM0919.

QA/QC Submission

With respect to the QA/QC Monitoring plan, the NWB received the Plan on February 1, 2010, and distributed the document for information purposes on February 16, 2010. A Submission was received from Indian and Northern Affairs Canada (INAC) Water Resources Division¹

The review of the Plan, which took into consideration the submission received, determined that the document is acceptable and consistent with the requirements of Part I, Item 8 of the Licence terms and conditions. However, to address minor issues raised by the intervening party, the Licensee shall submit to the NWB for review, revisions to be provided as an addendum to the Plan. Although this addendum may be provided to the NWB with the annual review of the plan, changes should be made prior to commencement of seasonal activities. These revisions are to include or address the following:

1. Submission of GPS coordinates and a map of the sampling sites for final discharge point of bermed fuel storage facility and final discharge point of sewage treatment facility.
2. Reminder that a written agreement between themselves and the hamlet of Cambridge Bay is required before any wastes are backhauled to the Hamlet's specified waste disposal site.
3. Submission was past the 90 day time requirement for the QA/QC plan as per water License 3BC-CAM0919

INAC Inspection Form

The 2010 Inspection Report dated August 2010 and received from INAC on September 29, 2010, was distributed for information purposes on September 30, 2010. No comments were received regarding the report at the time of review. There are no critical issues or concerns.
