Subject: Licence No. 8BC-ERK1621 – Review of 2015 Annual Report

Dear Colonel Horgan and Dr. Tam:

The Nunavut Water Board (NWB or Board) has completed its review of the 2015 Annual Report (Report) submitted by the Department of National Defence at 8 Wing – Canadian Forces Base Trenton on behalf of the Licensee, the Department of National Defence (DND), Real Property Operations, on March 31, 2016. The Report was submitted in order to satisfy relevant requirements under Licence 8BC-ERK1621 issued to allow for the use of water and deposit of waste during operation and maintenance of the Canadian Forces Station (CFS) Eureka, located on Ellesmere Island, within the Qikiqtani Region of Nunavut.

The Report states that the CFS Eureka was only operational for one month in June 2015; therefore, monitoring results were reported only for the month of June of 2015.

With the submission of this Report, the Licensee has satisfied condition under Part B, Item 1 of the Water Licence for the year 2015. However, the Board notices that 2016 Annual Report, due on March 31, 2017 has not been submitted yet. The Board would like to remind the Licensee that the Regulations, under s.14, include a legislated requirement for all licensees to submit an annual report to the Board. Furthermore, Annual Reports are for the purposes of ensuring that the NWB has an accurate annual update of Project water use and waste disposal during each reporting year.
