RE: AANDC Request for documents re: Fuel Storage – Water Use Inspection at Eureka Response Letter dated 29 October 2013.

Dear Mr. Hack,

1. The contaminated site located behind the large stationary fuel storage tanks at Canadian Forces Station (CFS) Eureka is the location of the former fuel bladders. This area of concern is included as part of a larger Federal Contaminated Site, CFS Eureka North Airstrip Apron (S-10527).

As requested in your letter dated 29 October 2013, the following copies of documents are provided:

- a. Contaminated Sites Final Reports for works completed in the years:
 - i. 2007/8;
 - ii. 2010/11;
 - iii. 2012/13.
 - b. DND's Contaminated Sites Datasheet Report for S-10527.
2. The 2007/8 and 2010/11 final reports focused on the entire contaminated site, including other additional areas to the south and east of the large stationary fuel storage tanks. The final report for 2012/13 focused specifically on the location referenced in your letter dated 29 October 2013 (the location of the former fuel bladders).
3. The Contaminated Sites Datasheet Report for S-10527 provides a summary of works completed. As described in the datasheet, the status is listed as 'under assessment' and having completed Step 4 of the 10 Step Federal Contaminated Sites Action Plan (FCSAP). The datasheet further shows that additional assessment and remediation works are required.

4. In the 2010/11 final report, FCSAP Step 8 was recommended as the next step in the contaminated site management process if the following conditions were conducted: 1) relocation of the large stationary fuel storage tanks; and, 2) construction of an engineered landfarm (biopile) facility to allow excavation of the contaminated site boundary.
