I would request from DND the following:

- 2) I am performing the Final Technical Review of the Application and have noticed the following:

The Spill Contingency Plan (SCP) dated November 2010 and the Abandonment and Restoration Plan (A&R P) dated February 2012 are outdated.

As a common practice, the Board usually requests that the licensee submits within the water licence renewal application updated versions of the plans. This information is maintained on the NWB Public Registry and is available to interested parties.

Assuming that the SCP and the A&RP reflect the current conditions at site, please, could you change the cover with the 2015 date (date the Application was submitted).

Hi Sonia,

Thank you for the clarification, my apologies for the long answer. For background, the DND is a large organization and

given the military function/roles, the names of individuals and positions routinely change every 1-2 years due to military postings. When I raised this staffing issue with Ms. Phyllis Beaulieu a few years ago, she had advised an email name change would suffice whenever these internal staffing changes occur or to include the updates in the Annual Reports.

Since the submission of the renewal (and amendment for CFS Alert) applications for both CFS Eureka (8BC-ERK) and CFS Alert (8AC-ALT), another name change in position had occurred.

The correct name of the Licensee should be:
Department of National Defence (DND)

For history of the names:

- 1) In 2010, the ERK licence was issued to: Colonel R.C. Baker and Scott Edwards (1 Canadian Air Division, Winnipeg) – Both have since retired. The ALT licence was issued to only Colonel R.C. Baker.
- 2) Colonel K.G. Horgan became the replacement for Colonel Baker (retired) at 1 Canadian Air Division, Winnipeg, so a name change occurred.
- 3) The DND has restructured internally and as a result, CFS Alert & CFS Eureka signatory management changed to Real Property Operations Group in Ottawa under Colonel D.O. Quinn.
- 4) Recently after the renewal application submissions, Colonel C.O. Quinn was posted out of this role and replaced by incoming Colonel K.G. Horgan (who moved from Winnipeg to Ottawa).

My apologies for the complication in the representative names and status, but this is always a big challenge when specific names/positions are required from DND as change and turnover occurs routinely.

Is there a better way to help manage this? Any advice would be greatly appreciated.

Good Afternoon,

This email is regarding the Water Licence Renewal Application for 3BC-ERK1O15 CFS Eureka, Nunavut.

The 2015 Application submission includes a Licensee Name Change Request, from the previous Colonel Horgan at 1 Canadian Air Division to Colonel D. Quinn, Commander Real Property Operations Group.

Colonel Horgan is not mentioned in the expired licence (3BC-ERK1O15), if you look at the first page of the water licence the draft licence was sent to Colonel Baker and Scott Edwards, these gentlemen were the representatives, not the licensee.

Licensee means a person (or company) to whom the licence is issued; the expired licence was issued to the Department of National Defence, 1 Canadian Air Division, the Licensee (see page i; Decision, page 1; and Water Licence, page 7).

Please, could you clarify if your intention were:

- a) to transfer the licence, changing the licensee from Department of National Defence to Colonel D.O. Quinn? or
- b) you just meant a change in the Licensee representative name?
