Hello Jean-Philippe,

Thank-you for submitting the request for modifications for Water Licence No: 8BC-EUR2131. During the preliminary technical review of the request, the NWB indicated several points requiring additional information:

1. The wastewater treatment plant and the greywater exfiltration trench are not included in the scope of the Licence and will require an amendment application(s). I see on the public registry that a somewhat similar option of greywater disposal was discussed between the NWB and ECCC on May 20, 2020. ECCC then chose to continue using the lagoon in lieu of applying for an amendment.
2. The engineering drawings require the Engineer's stamp/signature.
3. As a kind reminder, issued-for-construction drawings are required for all engineered infrastructure (e.g., the upgrades to the quarry access road) 60 days prior to construction.
