Thanks Louise, received.

Regarding your concern that four of the current licences are expiring at the end of February, if there is no one on site after the end of February there shouldn't be a problem as there will be no use of water or disposal of waste. Based on current staff resources it will be at least the end of April before the new licences can be issued, provided they are first approved by our Board. If there is still a concern, our recommendation is for DND to request an extension based on section 55.4 of the act. There would be a requirement to submit an application form and a letter to our Board justifying the urgent circumstances and requesting a six month extension. The Board would be more inclined to consider urgent circumstances as opposed to an emergency situation. Hope this helps. Any further questions, please don't hesitate to contact our office.

Phyllis,

This is the schedule for the four sites listed below:

There is no one at any of these four sites at the moment but we have scheduled visits as follows:

3BC-SHE0409 - CAM-3:	Due in today for a Preventative Maintenance Inspection (PMI) visit
3BC-FOD0409 - FOX-3:	Due in on 17th Feb for Preventative Maintenance Inspection (PMI) visit
3BC-DYE0409 - DYE-M:	Due in on 23rd Feb for Preventative Maintenance Inspection (PMI) visit
3BC-BAF0409 - BAF-3:	Due in today for a 2 day training visit

A PMI involves 4 staff for 4 to 5 days. In the course of the visit staff will use water for personnel hygiene as well as for cooking and cleaning. As a result both gray water and sewage will be produced. Dry waste is backhauled from the site. This is the same scenario for the two day training course.

It should also be noted that the above is for scheduled visits, there can also be an unscheduled visit resulting from a requirement for Corrective Maintenance.
