RE: DFO File No.: 18-HCAA-00168 Water Licence Amendment FOX-3, Dewar Lakes, Baffin Island

The Renewal/Amendment Water Licence Application FOX-3 Dewar Lakes (8BC-FOD) proposal has been reviewed to determine whether it is likely to result in serious harm to fish which is prohibited under subsection 35(1) of the Fisheries Act unless authorized. The proposal has also been reviewed to determine whether it is likely to affect listed aquatic species at risk, any part of their critical habitat or the residences of their individuals in a manner which is prohibited under sections 32, 33 and subsection 58(1) of the Species at Risk Act, unless authorized. Provided that the plans are implemented in the manner, and during the timeframe, described, the Program has determined that the proposal will not result in serious harm to fish or prohibited effects on listed aquatic species at risk. As such, an authorization under the Fisheries Act or a permit under the Species at Risk Act is not required.

Please be advised that under the Agreement Between the Inuit of the Nunavut Settlement Area and Her Majesty the Queen in Right of Canada (Nunavut Agreement) Article 11, Section 11.5.9 and s. 76 (1) of Nunavut Planning and Project Assessment Act (NuPPAA), the proponent of a project governed by NuPPAA is also required to submit a project proposal document (which may include the water licence application) directly to the Nunavut Planning Commission (NPC or Commission) for the NPC's determination regarding the applicable land use planning requirements and/or directions regarding whether the project is subject to screening by the Nunavut Impact Review Board. In particular, please note that as established under Articles 11, 12 and 13 of the Nunavut Agreement, NuPPAA and Part 3 of the Nunavut Waters and Nunavut Surface Rights Tribunal Act, until the project has completed the applicable land use planning and assessment process required by the NPC and the NIRB, the NWB cannot issue a water licence. The NWB confirmed receipt of NPC conformity under NuPPAA on January 12, 2018 and NIRB determination through NPC under NuPPAA on January 12, 2018 as well. This application is now ready for review and comments. Deadline for submissions is **March 12, 2018**. Inuktitut notice of the renewal/amendment will follow shortly.
