As did Dana, I am acknowledging receipt of your report from your 19 July 2014 visit to 4 sites south of Queen Maud Gulf.

Most importantly, we will take the required actions outlined in section 3 of your report. For the record, we will be addressing, point by point, all issues identified in your report in due time, as well as asking for points of clarification. For example, in some cases you referred to empty fuel drums collected in one place for removal, as a fuel cache, but there was no fuel deposited there as a cache; in fact, the empty drums were moved there from a spent fuel cache, so that they could be removed from site. But we will bring these questions up in our point by point responses or requests for clarification.

In any event, we will plan for some of the recommendations/requirements that you outlined, and working with you to rectify those issues that need to be remedied.
