Hi Eva,

I spoke to Sean recently about our permission request for open-burning of painted buildings upon abandonment. He indicated that they issue such permissions on a case-by-case basis, for a specific time frame. Because there are no plans to abandon these sites (i.e., there is no specific time frame), we surmised that rewording the Abandonment and Restoration Plan to indicate that we would ask for permission to open-burn when the time comes. Is this acceptable?

Hi Dana,

As a follow-up to our conversation on Friday, could you please confirm whether or not the Inspector is in agreement with Environment Canada's (EC) intention/approach to change the text of the relevant section of the Abandonment and Restoration Plan that reads "all buildings on site are constructed of lumber, and will be combusted".

If there is an agreement between the Inspector and EC that changes to the Plan will resolve the issue, EC might want to consider withdrawing its November 14, 2014 request to open-burn acceptable material upon abandonment of the site given that approval to open-burn acceptable materials are typically granted on an as-needed basis and that EC currently has not definite date/intentions to abandon the site.
