RE: NWB Technical Review of 2021 Annual Reports for the BAF-3, CAM-3, CAM-M, DYE-M, FOX-3 and FOX-M Long Range Radar and Logistics Support Sites; Water Licences Nos: 8BC-BAF1929, 8BC-CAM1929, 8BC-DYE1929, 8BC-FOD1828, 8BC-FOH1929 and 8BC-SHE1929.

Dear Mr. Wyman:

The Nunavut Water Board (NWB or Board) has completed a technical review of the 2021 Annual Reports (Annual Reports) for Type "B" Water Licences 8BC-BAF1929, 8BC-CAM1929, 8BC-DYE1929, 8BC-FOD1828, 8BC-FOH1929 and 8BC-SHE1929 (Licences). The Board acknowledged the receipt of the Annual Reports on March 23, 2022, which were submitted by the Department of National Defence (DND) as a requirement under part B, Item 1 of the Licences.

The NWB notes that the DND as part of annual reporting submitted updated Spill Contingency Plan (Updated Plan) for the North Warning System that applies to Water Licences Nos: 8BC-BAF1929, 8BC-CAM1929, 8BC-DYE1929, 8BC-FOD1828, 8BC-FOH1929 and 8BC-SHE1929.

Upon receipt, the submissions for Licences 8BC-BAF1929, 8BC-DYE1929, 8BC-FOD1828 and 8BC-FOH1929 were provided to the Qikiqtani distribution list, and the submissions for Licences 8BC-CAM1929 and 8BC-SHE1929 were provided to the Kitikmeot distribution list on March 23, 2022 for information. No comments have been received to date.
