Hello Richard,

I did a first review of the QAQC plans and noticed that some information are missing :

- 1) The Plans have to be related to the Water Licenses (Locations, etc.). The only information I see here are the Licenses numbers (from the name of the files) and the project numbers.
- 2) An introduction outlining the Surveillance Network Program would help to ensure the QAQC plan is complete.
- 3) While the Field Sampling and Lab analysis information is complete, the reporting requirements are not even mentioned.

I attach here the checklist that I use to review the QAQC plan to help you understand what information is missing.
