Hello Chris.

I have reviewed your Application for the Arctic Bay Harbour Development Project. We require a few documents to continue to process this Application.

Please send us an **Executive Summary** (English and Inuktitut) and a **Spill Plan** specific to this Application which, from our understanding, is for the diversion of small creek(s) through culvert installations.

It seems that the main construction activities are not included in the scope of this Application. According to the submission, construction works are planned to commence in July 2022, by a contractor who will be responsible for applying for a separate Licence for works including quarrying, access road upgrade, water use and waste disposal.

I have been advised to inform you that the Board is not keen on issuing two different Licences for the same project and will likely require an Amendment to the Licence to include the additional scope.

So for now, we can process the Application for the "diversion of small creek(s) through culvert installations" and later add "construction, quarrying, access road, water use and waste disposal activities" to the Licence via an Amendment.
