A. BACKGROUND

On August 6, 2025, the Board invited interested parties to comment on DFO-SCH's renewal application for the Arctic Bay Harbour Development Project, for Type B Water Licence No. 8BC-ABH2125.

The Project is part of the Inuit Impact and Benefit Agreement negotiated for the Tallurutiup Imanga National Marine Conservation Area, and it will improve safety and access to water, functionality of boating activities, and reduce the congestion and environmental risks associated with the current use of the harbour. The permanent components of the Project will include the construction of a new breakwater with a fixed wharf, a boat launch ramp, small craft floating docks, a laydown area, and harbour lighting.

There are seven (7) existing culverts that drain into the bay along the SCH shoreline. The project design redirects these culverts around the harbour with a series of ditches and new culverts to manage discharge. This is required to reduce sediment accumulation within the harbour and prevent future maintenance dredging. The water will be redirected through the site and discharged into the same waterbody.

During the initial review of the application, the Board inquired why construction activities requiring use of water and deposit of waste were not included in the scope. DFO-SCH advised the Board that specific details of water requirements for the construction phase (e.g., water use for the construction camp or dust suppression) will be provided in a subsequent application made upon hiring of the contractor. An amendment to the existing water licence would be required to include water use, waste disposal, construction, quarrying, and drilling activities.

CIRNAC provides the following comments and recommendations related to the renewal application for the Board's consideration. Section B outlines documents that were reviewed under the submission and Section C provides the result of the technical review.

C. RESULTS OF REVIEW

1. Scope of Construction Activities



Comment:

CIRNAC understands that the scope of Type B Water Licence No. 8BC-ABH2125 is primarily related to watercourse training or diversions of small water courses, along with the construction/installation of ditches and culverts. No consumptive water use or permanent waste disposal is authorized under this Licence. The Licensee noted that specific details, such as water requirements for the construction phase, will be provided in a subsequent application made upon hiring of a contractor.

CIRNAC is seeking clarification on the scope of construction activities in the proposed renewal for 8BC-ABH2125. There are provisions for construction activities in Part E of the Licence, and CIRNAC interprets that these provisions are applicable to the construction/installation of ditches and culverts to support water diversion activities. CIRNAC understands that the construction of other works associated with the development of the SCH would be reflected in a subsequent application. It appears that no construction activities have been undertaken to date, based on information in the 2021-2024 Annual Reports.

CIRNAC is also seeking clarification on the Licensee's intention to amend Type B Water Licence No. 8BC-ABH2125 before commencing construction activities. Table 2-1 in the Construction Environmental Management Plan (CEMP) appears to suggest there may be a separate Type B Water Licence held by the contractor, which is shown below for reference:

CIRNAC is of the view that the Type B Water Licence No. 8BC-ABH2125 should clearly define any construction activities, to enhance clarity and minimize overlap with other construction activities that are contemplated outside the scope of the current Licence (i.e., activities undertaken potentially under a separate Licence by another party).

Recommendation:

(R-01) CIRNAC recommends that the Licensee:

- Clarify the scope of works and activities associated with the renewal application, including whether construction activities are being contemplated.
- Confirm if the contractor will be seeking a separate Type B Water Licence.



2. Review of Terms and Conditions

Comment:

CIRNAC is of the view that clarifying the scope of activities in the renewal application is necessary to improve understanding of any planned works, which would help guide the selection of relevant Terms and Conditions and reporting requirements in the Licence.

CIRNAC notes that some Terms and Conditions in Type B Water Licence No. 8BC-ABH2125 may not be applicable to the current scope of the Project. For example, Part E, Item 1, describes that the Licensee shall not erect camps or store material on the surface of frozen streams or lakes including the immediate banks except what is for immediate use, but the Licensee noted that "...no camp will be required for the purposes of this NWB permit application".

CIRNAC also notes there is reference to an access road and pad construction in Part E, Item 8, but this infrastructure does not appear to be included in the scope of the Project at this time.

Recommendation:

(R-02) CIRNAC recommends that the Board review and update, as applicable, the Terms and Conditions in Type B Water Licence No. 8BC-ABH2125, to reflect the scope of the activities contemplated in the renewal application.
