The Nunavut Planning Commission (NPC) received a request for a conformity review (CR) from the Kivalliq Inuit Association (KIA), file # KVRW15F01 on April 14, 2015, and from the Nunavut Water Board (NWB), file # 150420 2BW MEL1215 on April 20, 2015 submitted by Agnico Eagle Mines Ltd. (AEM) for a development of an Access Road between the AEM Meadowbank Mine and it's Amaruq Exploration Property.

Before initiating it's conformity review, the NPC must be in receipt of all of the applications/project proposals from an authorizing agency related to the proposed project. Both applications listed above as submitted mention that the proponent also requires an Aboriginal Affairs and Northern Development Canada (AANDC) authorization. To date, the NPC is not in receipt of a copy of the AANDC application, therefore cannot initiate the review at this time. The NPC will formally commence its CR once AANDC forwards the related application.
