We have not yet received NPC conformity for 11EN010 - AEM's Amaruq Road Project to begin screening this application. You may wish to follow up with NPC for a conformity determination regarding this application. If you have received one could you please forward it to the NIRB so we may follow up with NPC.

For 12EN012 - Amendment to Stornoway Diamonds 2BE-QIL1217 Qilalugaq Project. On May 21, 2015 the NIRB requested a Ministerial extension to screen this application. Following the close of the Board's public comment period the GN-DoE requested that NIRB keep the public record open to allow submission of additional comments by GN-DoE. This outstanding submission is expected on May 22, 2015. We expect to complete the screening process by June 19, 2015.
