The idea to have steady meetings (one in summer and one in winter) with the date decided during the previous meeting</i> How far our impact study goes? <i>Discussed about our CREMP study and showed on the map the locations of our far field station (Tehek, Pipe dream Lake, Innug, ect..)</i> Questions on the caribou situation and the collaring <i>Ryan showed some maps of the caribou migration and explained some of the actions taken by AEM to ease the caribou migration.</i> More collaring to come? <i>Yes, we install 25 collars on caribou since 2011 and have a 3 years agreement for more collaring</i> How many caribou and total collars? <i>AEM is involved in the project but it's more Mitch Campbell of the GN who's in charge and could answer.</i> <i>It would be appreciated to have more cooperation with the harvest study (AEM)</i> For the Inuit, information about hunting is confidential information, that's why it's hard to have a good feedback Will AEM re-introduce fish in the flooded area where dikes will be breached? <i>It's a possibility to introduce fish as a test before breaching the dike.</i>

Will AEM continue monitoring after the re-flooded area?
Yes we will until 2040 or until the water is clean for all parameters

For the road heading to IVR, it's almost at the same location as the water line so it's possible to encounter different fish species from one side of the road to the other.
Thanks for the input we will let the fisheries consultant know of this information.

AEM requested a letter of support to conduct baseline studies for the proposed route. Letter of support signed by Hugh (HTO) and Ryan.
