Eric,

Thank you for this update related to file 8BC-BTN1819. The NWB looks forward to reviewing your revised construction plans and a gaining a better understanding of what the revised scope entails.

The NWB notes that the main consideration for your project to be Licensed as a Type 'B' project was the re-direction of the river around the work site. If the revised project no longer includes re-direction of flow, your project might no longer require a Type 'B' Licence. In that case, you could choose to request the board cancel Licence 8BC-BTN1819 and at the appropriate time apply for an Approval Without A Licence.

If your revised scope only drops out portions of the approved activities under 8BC-BTN1819, then an amendment might not extend beyond timelines for various submissions. If any 'new' activities have been added, the amendment would have to be a bit more extensive.

Please feel free to give me a call to discuss the different options. I am in the office Monday to Wednesday next week and then am on leave until mid-July.
