Re: 8BC-CLY2225 Clyde River Harbour Development Project by Fisheries and Oceans Canada - Small Craft Harbours- Construction Plans as per Licence Conditions

Dear Richard Dwyer:

On January 20, 2022, Fisheries and Oceans Canada – Small Craft Harbours (DFO-SCH) was issued a Nunavut Water Board (NWB) Type- B Water Licence for the Clyde River Harbour project (the Project). DFO-SCH's original application did not include construction work plans related to the specifics use of mitigation measures for the proposed construction. Subsequently, in issuing the NWB- Type B Water Licence, conditions were included for the submission, review, and approval of site specific construction work plans by NWB prior to construction commencing. Specifically conditions in the Monitoring Plan section, Part D-1, Part E-7, Part H-1, and Part J-1 require the submission of a Quarry Development and Blasting Management Plan, Waste Management Plan, Sediment and Erosion Control Plan, Spill Contingency Plan, and Water Quality Monitoring Plan, respectfully. The construction work plans are due to the NWB 60 days prior to construction, as per the Licence conditions.

On May 20, 2022, Public Works and Government Services Canada (PSPC), on behalf of DFO-SCH, successfully hired the contractor Pilitak Enterprises Limited (Pilitak). Pilitak has developed the site specific work plans to fulfill the pre-construction submittal conditions of the NWB- Type B Licence. Attached are the construction plans for NWB review.
