The Nunavut Water Board (NWB or Board) has completed its review of the 2014 Annual Report (Report) submitted on March 31, 2015 by the Department of National Defence in support of the relevant requirements under the Licence issued to the Nanisivik Naval Facility Construction Project, situated near Arctic Bay in the Qikiqtani Region, Nunavut.

The review determined that the Report is generally complete and consistent with the reporting requirements associated with Part B, Item 1 of Licence No. 8BC-NNF1418. Based on the details included in the report, the Board notes that no water use or waste deposit activities have occurred during the 2014 reporting period.
