On behalf of the Qikiqtaaluk Arctic Economic Development Corporation (QAEDC), we request to withdraw our application for a water license from the Nunavut Water Board (NWB) for the construction of the Qikiqtarjuaq Marine Infrastructure Project.

Following correspondence with the NWB, it is our understanding that the project will not require a water license for construction as:

1. There are no adverse effects on freshwater anticipated from the quarrying activities, and,
2. The deposit of marine sediments from dredging activities will be limited to the marine environment at the port development area.
